EVBCO also offers inexpensive file storage that is accessible 24/7 to its laws firms within the Park Building and for the security-minded firms, a separate CCTV system can be installed within their office to add an additional level of security to sensitive client files.

To accommodate the irregular hours that lawyers and firms tend to work, EVBCO has installed a sophisticated electronic keycard access system that gives each attorney building access all times of the day, while maintaining security for the rest of the building.
